- Regulations of the Belarus Rally Championship 2016;
- FIA, LASF and BAF automobile technical requirements;
- The present Supplementary Regulations.

IV. ENTRIES

- **4.1.** The entry will only be accepted if accompanied by the total amount of the Entry Fee.
- **4.2.** All competitors (first and second drivers), holding valid Driver's license issued by the LASF or other parental ASN (valid in this event). Competitor younger than 18 years is able to take part only if registered in the LRC classification by special ASN decision.
- **4.3.** Electronic entry form must be filled till the time limits specified in art. 3.1 of these Supplementary Regulations. Entry form is considered to be confirmed only when the entry fee is paid. FIA ERT Baltic Rally Trophy entries must be filled and paid till 2016-07-29 with no possibility to fill after this date. Data about the co-driver may be submitted during administrative checks.
- **4.4.** Entries accepted as follows:
- 4.4. Competitors, who want to participate in BYRC classification must submit entry form and have a valid BAF license. Drivers, who don't have nationality of Republic of Belarus and license of BAF, must submit a form to participate in BYRC classification. If the form is not submitted, team, which this driver represents, are participating in main event and are added to the overall classification. Only teams, who's first and second drivers meet the requirements mentioned above can participate in BYRC classification.

Only teams, which have BAF category "K" registration certificate and consists of three cars, can participate in BYRC classification.

4.5. The Organizer have the right to limit the maximum quantity of participants in the event.

4.6.4. The eligible vehicles to participate in the Rally classification shall be the cars that meet above technical and safety requirements. This means the WRC cars with expired homologation must comply with expired (not necessarily the latest) WRC homologation of that car as well as 255 article of FIA Appendix J of the same year of expiration.

4.7. Entry fees

If paid after indicated deadline the increased entry fee must be paid till 2016-08-10 17:00.

- **4.7.4.** Participants who compete in FIA ERT Baltic Rally Trophy, LRC or BYRC classifications pay one starting fee, corresponding to classifications noted in clause 4.7.1, 4.7.2 or 4.7.3. If there is a difference between fees for FIA ERT Baltic Rally Trophy, LRC and BYRC classifications the bigger fee must be paid.
- **4.7.5.** Participants, who do not participate in neither FIA ERT Baltic Rally Trophy, LRC, BYRC classifications, pay starting fee corresponding to classifications noted in clause 4.6.2.

4.9. Refunding of the entry fee

4.9.1. The organiser may refund part of the entry fee (50%) to those competitors who, for reason of "force majeure" (duly certified by their ASN, before the Administrative Check), are unable to start in the rally. This must be applied for in writing (info@300lakesrally.lt), giving the reason of withdrawal, before the Tuesday the 11 of August (Administrative Checks), including bank and account details.

In case the Rally is cancelled due to Force majeure, Participants will be refunded 100 percent of their entry fee paid. If the entry form is rejected – full entry fee is refunded.

4.10. The registration of Zero Car crews

Zero Car crews that are going to participate in the rally must pay 250 EUR deposit before 2016-08-10 17:00. The deposit will be returned if the crew will accomplish all regulations for Zero Car crews that the organizer will give and if the crew wouldn't produce or have an accident. E-entry form for Zero Car crews is published at www.300lakesrally.lt.

4.11. Prohibited entry zones (Forbidden zones)

4.11.1. Every 1st and 2nd driver who participates or intends to participate in FIA ERT Baltic Rally Trophy, LRC, BYRC and/or in "300 Lakes Rally 2016", are strictly prohibited to be in prohibited entry zones from 2016-06-30 11:00 until 2016-08-11 8:00. Those, who are registered as violators by the Officials appointed by the LASF or the Organiser, will not be allowed to take part in the Rally and LRC 2016 participants will be excluded from championship. The corresponding ASN's will be also informed about the violation.

The map of the restricted roads (Appendix No. 6) is announced: www.300lakesrally.lt, www.lasf.lt.

4.11.2. Persons, named in clause 4.11.1., willing to move/cross the roads marked in prohibited entry zones map, must communicate their intentions in writing in advance to the Organiser by email: neringa@300lakesrally.lt and subsequently obtain a written permission from the Organizer. The Organizer must publish the permission in it's website.

V. INSURANCE

5.1. Every Participant must hold valid User/driver civil liability insurance or the "green card" (for both: the reconnaissance car and the race car).













- **5.2.** The Organizer guarantees civil liability insurance towards third party, made as consequence of a crash on the special stages. Participants are not third parties to each other.
- **5.3.** Insurance is valid from the start of the Shakedown or the free practice and the Qualifying stage, as well as when the crews are driving on the rally route (except cases, mentioned in clause 5.4.) from the start of first part of the competition until the finish or until the point, when the crew retires or is excluded from the competition. Crews that had retired, but restarted the competition are not considered as retired from the whole competition.
- **5.4.** Rally insurance is not valid for service and reconnaissance vehicles, even if they are marked with Organizer's stickers. Insurance is also not valid in liaisons during reconnaissance, where Participant must obey the Rules of Traffic and must take on responsibility for his/her actions.

VI. ADVERTISING AND VEHICLE IDENTIFICATION NUMBERS

- **6.1.** The positioning of the advertising material for LRC participants (start numbers, Rally and advertising stickers), provided by the Organizer, is presented in the Appendix No. 1 of Regulations of the Lithuanian Rally Championship 2016 (Regulations Appendix No. 3) and this advertising is mandatory.
- **6.2.** Rally plates, rally and sponsor's stickers provided by the race organizers placement scheme is provided in Belarusian Rally Championship Regulations 2016, appendix No.2.
- **6.3.** Only advertising, start numbers and rally logo, issued by the Organizer, is mandatory for Participants, who are not participating in FIA ERT Baltic Rally Trophy, LRC, BYRC.
- **6.4.** Loss or removal of competition numbers and advertising. Missing advertising: cash penalty of 100 Eur. Rally Organizers Optional Advertising failing to be visible or partially covering: cash penalty of € 100.

VII. TIRES

- **7.1.** The tires used by the competitors during reconnaissance must be certified for the public traffic usage and comply with the Road Traffic Rules of Lithuanian Republic (not allowed to use M+S marked tires).
- **7.2.** It's allowed to use only gravel tires.
- **7.3.** All competitors allowed to change tires at Service Park "A", "B", "C", "D", "E".
- **7.4.** The number of tires for the competition is not limited.
- **7.5.** During rally, tires will be marked by dedicated persons, after leaving service zones.
- **7.6.** Tire cutting is forbidden for participants, who are participating in FIA ERT Baltic Rally Trophy and BYRC classification.

VIII. FUEL

- **8.1.** Refuelling is only allowed in the refuelling zones (clause 58.1.1. of T-2016). To access the refuelling zones each service crew member (maximum of 2) will have to wear fireproof protection or close type clothing. Also crew member in the refueling area shall have fuel sorbent. Infridgement of these requirements cash penalty of € 100.
- **8.2.** Rally cars of every Participant, using E85 fuel bioethanol, must be marked by special stickers (min. measurements: 160x120 mm), where white note E85 must be written on blue background. Height of the letter and the digits is: 80 mm, symbol thickness: 14 mm. Stickers must be stuck on car bodywork, above rear wheel arches no further than 200 mm from top of the arch (on both sides of the car). It is prohibited for Participant to start in the Rally with the marking missing. FIA ERT Baltic Rally Trophy participants are restricted from using E85 fuel.

IX. RECONNAISSANCE

9.1. Participation in reconnaissance is mandatory. The reconnaissance schedule is not applied. Reconnaissance control cards are not in use.

Competitors are permitted a maximum of two passages over each special stage during reconnaissance (including the qualifying and shakedown stages).

The reconnaissance of SS12 can be done only without car. The time and number of passages unlimited.

SS1/2, SS3/4, SS5/8, SS7/9, SS10/11 are identical, therefore the reconnaissance is limited to two passages (with the road section (SS1/2), which has a special marking in the Road Book, is able to do reconnaissance only without car).

The number of passages during the reconnaissance will be controlled by the judges of the fact mobile crew and GPS tracking devices.

9.2. During the reconnaissance the crew must drive in such a way that no danger or inconvenience is caused to the people residing close to the Rally course. Driving in the opposite direction on the special stages is strictly prohibited,













except segments of SS6, SS7, SS9 on road Nr.179 "Dusetos-Degučiai", where SS7/9 coincides with SS6. Reconnaissance speed in these segments will be indicated in road book. The speed during the reconnaissance will be controlled by the Organizer's officials, police and GPS tracking devices. The speed limit can be reduced by the signs provided in the Road Book.

Speeding up to 10 km/h during the reconnaissance will be not considered as infringement and will be not fined.

All infringements of the Traffic Rules offended during the reconnaissance and reported by the judges of the fact, police and GPS devices will be fined as follows:

For the first infringement:

- speed exceeded between 10 km/h and 20 km/h inflicts 12,00 EUR penalty for each exceeded km/h;
- speed exceeded between 20 km/h and 40 km/h inflicts 20,00 EUR penalty for each exceeded km/h.

For the second infringement: speed exceeded between 10 km/h and 40,00 km/h inflicts 20,00 EUR penalty for each exceeded km/h.

For the third infringement or speeding more than 40 km/h: Stewards are informed about the infringement and impose the sanction.

For speeding in liaisons during the Rally – the Clerk of the Course will inflict 15,00 EUR penalty for each exceeded km/h and speeding more than 30 km/h inflicts 1 min. time penalty. If speed is exceeded more than 30 km/h, additional time penalty will be given, according LRC Regulations' clause nr.28 of Appendix 3. Other violations made during the reconnaissance will be reported to the Stewards, who will appoint penalties following Art.152 of the LASC. National federations will be given respective notice. Penalties, given by the Traffic Police, do not reduce penalties, given by Marshals.

9.3. Any fines for infringements during the reconnaissance should be paid by the offender in 48 hours.

9.4. Reconnaissance vehicles

- **9.4.1.** Reconnaissance is allowed only in vehicles, whose exhaust, it's noise level and other parameters are in conformity with Rules of Traffic of Lithuanian Republic.
- **9.4.2.** Maximum persons allowed to drive in car during the reconnaissance -2 persons. Other persons can be in the same car during the reconnaissance only if they get an approval from the Clerk of the Course. Crews will only be permitted to enter and leave special stages through the start and finish of special stage.
- **9.4.3.** If the crew will change its car during the reconnaissance, it must be reported to the rally center.
- **9.4.4.** Any driver holding an appropriate license but not entered in the rally may apply to take part in the reconnaissance. The regulations on reconnaissance must be respected in their entirety. Registration e-form is available on website. The final permission for taking part in recce is left to the discretion of the Clerk of the Course. An administrative fee of € 100 will be charged.

- Driving licenses for both crew members (except under age 18 years);
- Medical certificates of aptitude (068/a or FIA Sports Code, Appendix "L" art. 1.8);
- Foreign competitors (except for FIA ERT Baltic Rally Trophy, LRC and BYRC participants) permission from an ASN to take part in the rally.

- **10.5.** Teams will be able to choose desirable time of administrative check in an online e-form, available on www.autorally.lt/300LakesRally, www.300lakesrally.lt from 2016-08-03 16:00 till 2016-08-08 16:00.
- **10.6.** The procedure of issue and use of safety and tracking equipment. In pursuance to maintain safety, receive notifications of risk and following to Regulations of the Rally, at the administrative checks for every competitor will be issued EDGE/3G/GPS and satellite communication GPRS/GSM/GPS equipment that will have to be used by every competitor during the reconnaissance and the Rally. Every competitor is responsible financially for the equipment during the reconnaissance and the Rally. Every crew must pay 200,00 EUR deposit fee.
- **10.7.** Safety and tracking equipment is issued during administrative checks. Return of the equipment and deposit return after Rally finish until 2016-08-13 23:00. The crew, which retires from the Rally earlier, has to return the equipment to Rally Headquarters until 2016-08-13 23:00. If a disordered, dysfunctional equipment is returned or if it has been failed to return until the term, the deposit fee is not returned.

11.1. Pre-start scrutineering: 2016-08-11 08:30 – 21:00 Šiaulių str., Zarasai.

The schedule for administrative checks will be published on 2016-08-09, 15:00.

- 11.2. Lateness to the scrutineering: 6 Eur/ for every minute.
- 11.3. During the pre-start scrutineering the Participants must present the following (valid) documents:
- "Green card"/user/driver civil liability insurance;
- vehicle registration document;
- technical inspection pass;
- rally car certificate issued by the LASF/BAF or the ASN of other country;
- Declaration of safety equipments;
- Declaration of used fuel.
- **11.3.** The crew must affix competition numbers and Rally stickers on their cars before scrutineering. Competition numbers and Rally stickers will be issued during the administrative checks.
- **11.5.** Checking of driver's helmets and driver's equipment will be performed by Officials, marked identifying signs, during the pre-start scrutineering also in the Service parks and in closed parks or in equivalent status zones.
- 11.6. FHR ("Frontal Head Restraint") devices are obligatory for all Participants.
- **11.7.** There will be no Parc Ferme after the pre-start scrutineering.
- **11.8.** Teams will be able to choose desirable time of scrutineering in an online e-form, available on www.autorally.lt/300LakesRally, www.300lakesrally.lt from 2016-08-03 16:00 till 2016-08-08 16:00. The schedule for scrutineering will be published on 2016-08-09 15:00.

XII. OTHER PROCEDURES

- **12.1.** Official competition time EEST.
- **12.2.** Rally start:: 2016-08-12 (Friday) Time: 16:30. Place: TCO (coincides with start zone, the square in front of Zarasai District Municipality, Sėlių sq. 22, Zarasai).
- 12.3. Driving through GPS Safety and Tracking zone (marked on the Road Book) is obligatory to all Participants.
- **12.4.** Time cards will be <u>issued at</u>: TC0, TC1A, TC4E, TC6A, TC9A, TC-11A; <u>collected at</u>: TC1A, TC4D, TC6A, TC9A, TC11A, TC12A
- 12.5. Early check-in is allowed in: TC4C, TC4D, TC12A.
- **12.6.** 2016-08-13 last four crew's who will start in SSS12, participation in press conference is mandatory. Due to press conference, lateness to TC12A is allowed for these four crews Each competitor, who did not attend Press Conference, will be fined 60 EUR fee.
- **12.7.** Any competitor retired from the rally, should report to rally headquarters reason, time and place of retirement by the phone, which number is specified on the safety and tracking (GPS) equipment sticker. Also the retired competitor must return the time card to the nearest TC marshal at the end of the special stage or to return to the final (last) car "SAF Finish" which follow after the last competitor. Offenders of the above requirement could be fined by the Clerk of the Course (the fine for above mentioned requirement 60 EUR).
- **12.8.** In case the competitor gets into accident, causing spectators or competitors injury, the crew member must immediately inform not less than 3 following crews about the accident by showing "SOS" sign (T-2016, 40.2 p.) and contacting by the phone, which number is specified on the safety and tracking (GPS) equipment sticker with Rally Headquarters. Infringement of "OK"/"SOS" signs usage requirements will be fined by the Stewards decision according to LASC Article No. 12.
- **12.9.** Participants, who retired from the rally after the crash or after off-road accident, must inform Chief of scrutineering committee and deliver their car for technical inspection. The crew violating this requirement will be penalized.













- 12.10. The competitors must follow the marshal's instructions for driving at the ceremonial start.
- **12.11.** For LRC participants SS11 will get "Power Stage" status.

12.12. "Rally 2" system.

- **12.12.1.** LRČ participants, retired from the first leg of "300 Lakes Rally 2016" after a crash or an off-road accident, are allowed to restart in the second leg only in the following conditions:
- Any competitor who restarts will not be classified in the final classification and thus not be eligible for Championship points, except bonus points for classification of each leg of the Rally and last SS;
- In separate cases, following the decision of Clerk of the Course, competitor who restarts after the accident, must get a permission of Chief Doctor;
- Intention to restart must be made by filing the Rally committee approved request form following the requirements of T-2016 art. 46.
- **12.12.2.** Participants, who do not compete in LRC, may start under a "Rally 2" according to order, described in clause 12.12.1.

12.12.3. "Rally 2" system in Belarus rally championship.

Participants, retired from the first leg of "300 Lakes Rally 2015" after a crash or an off-road accident, are allowed to restart in the second leg only in the following conditions:

- Any competitor who restarts the rally according "Rally 2" system will be applied a 5min penalty, added to the fastest crew's time, who are participating in same classification ("B-12","B-11","B-10"), for every SS or SSS that the crew missed or did not finish. If crew retires after last SS or SSS a 5min penalty will be applied.
- In separate cases, following the decision of Clerk of the Course, competitor who restarts after the accident, must get a permission of Chief Doctor;
- Intention to restart must be made by filing the Rally committee approved request form following the requirements of T-2016 art. 46.

Participants that start to Rally 2 system must be parked cars to Parc ferme until 9:30.

12.13. Start procedure for special stages.

On the start position the crew stops when instructed by marshals.

When the start marshal confirms the car is on the right start position – which is 40 cm before the electronically controlled start line the car must stop and stay immobile until the start moment and the team must visually follow the light signals on the light shield.

On the light shield the astronomical time will be shown.

30 seconds before the start the marshal passes to the co-driver the Time Card.

25 seconds before the start the remaining seconds to the start will be shown on the shield.

The last 5 seconds of the pre-start minute are indicated by five red light signals.

When all signals go out, the road for start is free. If the crew's car crosses the electronically controlled start line before the red lights have gone out, automatically will be fixed false start which will be indicated with 5 seconds delay.

The final decision about a false start is made by the start marshal by making a note in the start protocol. If the start system does not function, start will be given by a marshal in accordance with the LASF Rally regulations.

12.14. Service park: Sėlių sq. – Šiaulių str., Zarasai.

For rally cars and service crews service park opens at: 2016-08-11 8:00.

Service park opens for public traffic from 2016-08-13 22:00.

- 12.14.1. During the Rally servicing of rally cars shall be allowed in the service parks specified in the Road Book only.
- **12.14.2.** It is forbidden to wash the rally cars, parts and machineries that are using technical oils (engines, gearboxes, and similar) in Service Park.
- **12.14.3.** Only one service car of each crew is allowed into the service park. Special sticker issued by the Organizer must be stuck on the service car front windscreen at the top corner of the passenger's side. In case of failure to meet this requirement will be penalised with a fine. No reconnaissance cars are allowed to enter the service park.
- **12.14.4.** Standard service space for 1 crew is 54 m2 (6x9m). Additional Service space can be acquired by € 10/m2

The entrant has to send the exact dimensions, and crew numbers of his service area to <u>info@300lakesrally.lt</u> latest by Monday 1 August 2016. All changes after that deadline will be charged – 50eur/per 1 change.

- **12.14.5.** At the place of servicing in the service park, the waterproof fabric (minimum 4x4 m) must be laid under a rally car. A container must be laid under the place of the neck for tank filling (to collect fuel spill) in the refuelling zone. Using pumps for refuelling, the ends of the tube must be equipped with safety taps or valves.
- 12.14.6. Trailers and other vehicles must be parked in the territory of Zarasai Bus Parc at Statybininkų str. 2.
- **12.14.7.** The Refuelling Area will be situated at the exit of the Main Service Park and followed by the Tyre Marking/Reading Area. A car may be pushed out of the zone by the crew, officials and/or two team members without incurring a penalty.

12.15. Regrouping. There will be 5 regroupings during the rally:

- change of the starting order-consolidations according to the results SS 1;
- change of the starting order according to the results SS1-4;
- change of the starting order-consolidations according to the results SS1-6;
- change of the starting order-consolidations according to the results SS1-9;
- change of the starting order in reverse according to the results SS 1-11.

12.16. Shakedown

- **12.16.1.** Shakedown is free of charge for participants and limited for 2 times for each crew. Shakedown stage length: 3,24 km. Stage surface: gravel.
- 12.16.2. To participate in shakedown, the crew must have passed administrative check and scrutineering.
- **12.16.3.** Information about participation must be specified in E-Entry form.
- **12.16.4.** Safety and tracking (GPS) equipment have to be installed during the Shakedown. At special area (marked on the Road Book) the system must be shown to the Organizer's representatives for checking equipment's proper installation.
- **12.16.5.** The reconnaissance of Shakedown will be restricted to 2 time for each crew. Organizer does not guarantee possibility of 2 times of reconnaissance for all participants. Upon organizers decision, Shakedown start can be done with 2 minutes interval due to wheather conditions.

12.17. Free practice and Qualifying stage

- **12.17.1.** First twenty crews, according to the tentative start order, are participating in Free Practice. Participating in this stage is free of charge.
- **12.17.2.** Free Practice and Qualifying stage are non-mandatory. Participants, who refused to take part in them, are appointed start positions according to the tentative starting order sequence after the positions are chosen by Qualifying stage participants.
- **12.17.3.** Crew, who suffered a crash or mechanical problems in the Free Practice, Qualifying or Shakedown stage, must attend the celebratory start ceremony unless the Clerk of the Course decides otherwise. The abovementioned crew must inform Chief of Scrutineering Committee and deliver their car for technical inspection.
- **12.17.4.** Crews, participating in Qualifying stage, must have been completed administrative checks as well as scrutineering and have the start numbers and the rally advertising stickers stuck on their race cars. The race cars must have GPS Safety and Tracking equipment installed as well.
- 12.17.5. Free practice runs are limited to 2 times.
- **12.17.6.** Crews start in 2 min. intervals in the Qualifying stage.
- **12.17.7.** Crews start in 1 min. intervals in the Free Practice and Shakedown stage.
- **12.17.8.** Ten crews, who achieved best results in the Qualifying stage, must attend start position' choosing ceremony. Fastest crew will choose their starting position first, a second-placed crew will be second in the row to choose, etc. A crew, that has failed to arrive or was late to the ceremony for choosing start positions, is last to choose their starting position or is appointed with unchosen start position. Should more than one crew has failed to arrive or was late to the ceremony, then an appointment of the free start positions is done according to the sequence of the Qualifying stage start order
- **12.17.9.** A crew, that has failed to finish a Qualifying stage, is the last to choose its start position. Should more than one crew has failed to finish a Qualifying stage, positions are chosen according to the sequence of the Qualifying stage start order.
- **12.17.10.** Early or late check-in in Qualifying stage TC (TCQS) is considered as an infringement, inflicting procedures, stated in clause 12.17.9.
- **12.17.11. False start.** Any false start in the Qualifying stage is considered as an infringement, inflicting procedures, stated in clause 12.17.9.
- **12.17.12. Service for Free Practice and Qualifying stage participants.** From the beginning of the timetable for Free Practice until the individual start time of the Qualifying stage, service may only be carried out in the main service park or the service park designated by the organiser for this purpose. Any service on a car once it has started the Qualifying stage













is prohibited. All cars which participate in the Qualifying stage must immediately and directly be brought to the parc fermé designated by the organiser and remain there until released by the Stewards.

12.18. Super Special Stage (SSS).

Surface: gravel. The competitors will start the SSS in pairs of two in reverse order after the regrouping. The competitors must start SSS on concrete surface. After the last two competitors pairs finish the SSS, the crews must follow instructions of the marshals and drive the rally cars near the scene and to take part in the press conference.

12.19. GPS Safety and tracking equipment:

12.19.1. Safety and tracking equipment principles. Security and tracking devices are connected to a monitoring centre that stores all data received. All data is stored on the same device. The device has a self-contained power supply that operates throughout the rally. The device has "SOS" and "OK" buttons. Each device has a unique serial number that is assigned to each crew. During the event the Rally HQ will monitor the position and speed dating of each crew.

Attention! The device during its operating time can spread specific radio magnetic interferences what is typical for GSM connections. We kindly recommend putting other devices that can be sensitive for this Organizer's issued equipment in maximum distance from the installed Organizer's equipment.

12.19.2. The procedure of issuing and returning of safety and tracking equipment. Safety and tracking equipment is issued during administrative checks. The competitor have to uninstall the equipment by themselves. The competitor or his representative persons have to return the equipment to Rally Headquarters (Zarasai District Municipality, Seliu sq. 22, Zarasai) until 2016-08-13 23:00. If the equipment was not delivered until that time, the deposit will not be returned.

12.19.3. The use of safety and tracking equipment. The competitor is responsible for installing of equipment and the information sticker by himself. The same device is used during the reconnaissance and the event. During the reconnaissance the device has to be installed in visible place that marshals and other official rally persons could identify it.

The crew which will not use the device during reconnaissance, not installed device or dismounted the device during the rally will fined 1000 EUR penalty and must install the device immediately. For repeated infringement the competitor will be fined 300 EUR penalty fee.

The device has to be installed into the rally car **before Rally start** or if the competitor is attending to the Shakedown or Qualifying stage – before the start in Shakedown or Qualifying stage.

Any attempt to tamper with, to manipulate or to interfere with the tracking device fitted to the competition car or any device that fails to record a trace due to external interference will be reported to the Stewards who may impose a penalty up to exclusion.

12.19.4. Safety and tracking equipment including the information sticker has to be installed into the rally car according to the scheme specified in Appendix No. 9.

The system must be shown to the Organiser's representatives for checking at special area (marked on the Road Book) 2016-08-12 16:15. Driving through this special area for inspection of safety and tracking equipment is mandatory for all competitors. The crew which have installed the tracking equipment improperly must to install it properly until Rally start.

12.19.5. Principles of sending "SOS" and "OK" signals.

By pressing a "SOS" button a crew reports an accident and requests an immediate assistance. In this case, it is obliged to inform the Rally HQ, call the telephone number indicated on the info sticker. In case of an accident or technical problems during SS, by pressing an "OK" button a crew informs of the stop for more than 30 seconds and that immediate assistance is not required (even if a crew is trying to continue the rally). Attention! In case of stopping at SS, the device sends a "SOS" signal and the crew within 30 seconds must press "OK" button to remove the "SOS" signal sent by the system. A mobile phone of the crew must be switched on (or turned on in 60 seconds) so the rally control and monitoring centre can reach the crew. Irregularities in the wrong "SOS" and "OK" signal transmission will be punished. For the infringement, regarding to sending order of "SOS" and "OK" signals, the crew is fined according to Art.12 of the LASC.

12.19.6. Crew contact number. At the Administrative checks all crews will have to declare the number of the mobile phone, which they will carry with them on board and keep connected during the whole event, or connect within 30 seconds when they stop their car during a special stage. This is part of the crew safety procedures of the events safety plan. The Clerk of the Course will report any crew, which is able but fails to comply with this rule, to the stewards.

12.20. Parc Ferme

2016-08-12 – Parc Ferme after the finish of qualifying stage (for qualifying stage participants).

2016-08-12 – after the first leg – overnight Parc Ferme.

2016-08-13 – Parc Ferme after the rally finish, in Zarasai Island.
