I. INTRODUCTION

1.1 **DEFINITION.** The 4th event of 2018 Lithuanian Automobile Rally Sprint Championship (hereinafter - LARSC) and 5th event of 2018 Latvian Rally Sprint Championship (hereinafter - LRSC) „VIEKŠNIAI 2018“ will be organized by Mažeikiai Auto Sports Club. Rally Sprint will be run in compliance with:

- ❖ FIA International Sporting Code (hereinafter - FIA Code);
- ❖ Lithuanian Automobile Sports Code (hereinafter - LASC);
- ❖ Lithuanian Automobile Sports Competition's Organization and Execution Rules;
- ❖ Lithuanian Rally Rules 2018 (hereinafter - T-2018);
- ❖ Regulations of the Lithuanian Automobile Rally Sprint Championship 2018;
- ❖ Regulations of the Latvian Rally Sprint Championship 2018;
- ❖ Federation International Automobile (hereinafter - FIA) technical regulations;
- ❖ Lithuanian Automobile Sports Federation (hereinafter - LASF) technical regulations;
- ❖ The present Supplementary Regulations.

4.2 All drivers can take part in 2018 Lithuanian Rally Sprint Championship, Latvian Rally Sprint Championship or only Rally Sprint „VIEKŠNIAI 2018“ classifications, presented Entry Form and entry fee payment, holding valid driving license (except younger 18 years old), and LASF issued „E, D, DJ“ or analogical competitor's licenses, issued by parental ASN valid in this event. In LARSC Persons aged 16 or over are allowed to the first driver's position, but younger 18 years person is able to participate only by one axle powered car, with engine capacity up to 2000 ccm. Person who does not meet these requirements may be allowed take part only by LASF Rally Committee decision. For second driver's position allowed persons from 14 years old. All participants of Lithuanian Automobile Rally Championship and Lithuanian Automobile Rally Sprint Championship must submit "Championship Entry Form".

4.3 The electronic entry form, published www.autorally.lt must be correctly and fully completed till deadlines specified in part 4.1 of these Regulations. Entry form is considered accepted after receipt of the Organizer's confirmation and having paid entry fee. Data about the co-driver may be submitted during administrative checking.

4.3.1 Correctly and fully filled and **signed** original entry form is presented during administrative checking. By signing the entry form participant agrees that information, provided in the entry form is true.

4.3.2 Arrival times to the administrative checking and scrutineering may be booked from 15-08-2018 (Wednesday) 15:00 till 17-08-2018 (Friday). Indicate in electronic entry form, published www.autorally.lt

4.4 Eligible vehicles.

4.4.1 Eligible vehicles in LARSC (classifications, groups, classes):

SG1, SG2, SG3, SG4, OPEN, 2WD, (LARSC Regulations part. 5.1.1 – 5.1.2).

4.4.2 Eligible vehicles in Latvian RSC (classifications, groups, classes):

1600, 4WD, 2WD Open, 4WD Open, “Klasika 3000” (LRSC Regulations part. 4.1.1 – 4.5.1).

4.4.3 All cars, listed in points 4.4.1 and 4.4.2 can participate in Rally Sprint „VIEKŠNIAI 2018“ classifications, which are divided into classes **2 WD** (single axle drive) and **AWD** (two axles drive).

4.7 Partial refunding of the entry fee. If the crew, that has paid the entry fee, fails to appear in the event due to a serious reason, such crew may be refunded 50 percent of their entry fee payment. In case the competition is cancelled due to *Force majeure*, participants will be refunded 50 percent of their entry fee payment. If the entry form is rejected – full entry fee is refunded. Test stage entry fee is returned only in case if Test stage is canceled due to *Force majeure*.

4.8 “0” crews (“course” cars) must pay **150 Eur deposit** to the Organizer till 17:00, 17-08-2018 (Friday), which will be returned, if all of the Organizer appointed functions were carried out properly, according to the official report of the Clerk of the Course.

4.9 Prohibited Entry Zones.

4.9.1 All the first and second drivers of 2018 Lithuanian and Latvian Rally Sprint Championships and all sportsmen intending to take part in the Rally Sprint „VIEKŠNIAI 2018“ shall be strictly prohibited entering the roads, marked in the prohibited entry zones map from 16-07-2018 (Monday) 15:00 till the time limits, specified in the prohibited roads map (Appendix No. 5 of these Regulations). **The prohibited roads map (Appendix 5) announced on websites www.mazeikiuask.lt, ww.autorally.lt, www.lasf.lt, www.laf.lv starting from 16-07-2018 (Monday), 15:00.**

4.9.2 Persons named in clause 4.9.1, willing to move/cross the roads marked as prohibited for entry, must communicate their intentions in writing in advance to the Organizer and obtain the permission.

V. INSURANCE

5.1 Every participant must hold valid User/driver civil liability insurance (“green card”) for the race car.

5.2 Organizer guarantees civil liability insurance towards third parties in the special stages from the start to the finish, either his retirement or expulsion from rally. Participants are not third parties to each other.

5.3 Rally insurance policy is not valid for the service and recce cars, even if they are marked with special stickers issued by the Organizers. The ban also is not valid during reconnaissance and in the roads between special stages, where participants must comply with road traffic law and assumes civil liability for their actions.

5.4 About damage to property of third parties in the special stage crew must inform competitors relations officer at latest by the end of the rally. The failure to comply with these rule, will be penalized 100 EUR fine for each case of violation. The fine, after the end of the competition appoints LASF, according to the Organizers written notice.

VI. ADVERTISING AND VEHICLE IDENTIFICATION NUMBERS

6.1 The positioning of driver's names, surnames, competition numbers and advertising material provided by LASF or the Organizer is presented in Appendix 1 of 2018 LASSC Regulations and in Appendix 4 of these Supplementary Regulations. This advertising is mandatory.

6.2 Losing or removal of Start (car) numbers, rally and advertising stickers. During the event, if are lost in 6.1 point mentioned stickers, the crew must inform competitor's relations officer till the nearest service area or rally finish. Failure to do it, also intentionally removing of mentioned stickers during the event, will be fined by the Stewards decision or the crew will be expelled from the competition.

VII. TIRES

7.1 During reconnaissance (including Test stage) allowed use only EU certified tires, which are in conformity with Lithuanian Road traffic law for using during the summer season on public roads.

7.2 During the rally allowed to use only intended for gravel roads racing tires.

7.3 All participants are allowed to change tires in the Service park, mentioned in Road and Service books.

VIII. FUEL

8.1. Refuelling is allowed only in the refuelling zones (clause 58.1.1 of „T-2018“).

8.2. All cars using E85 fuel – bioethanol, must be marked by special stickers (min. measurements: 160x120 mm), with note E85, which must be written on blue background. Height of the letters and the digits is: 80 mm, symbol thickness: 14 mm. The stickers must be glued on car bodywork above rear wheel arches – no further than 200 mm from top of the arch on both sides of the car. **Without this marking prohibited start in the rally.**

IX. RECONNAISSANCE

9.1 Reconnaissance is mandatory for every crew. Only the crews, participating in Shakedown, allowed to recognise with this stage.

9.2 Any violations of the crews during reconnaissance will be recorded by GPS („Global Positioning System“) devices and Organizer's authorized officials.

9.3. The crew, that is not using this equipment during reconnaissance, has not installed the equipment or has dismantled it during the race, is penalized 300 Eur fine and must install the equipment immediately.

If an infringement is repeated, Stewards will impose an additional penalty or decide on the expulsion of the crew from the competition. The device must be in a easily visible place of the car during the reconnaissance, that Marshals or other Officials could identify it easily.

9.4 During reconnaissance must be followed schedule specified in Appendix 2 of these Supplementary Regulations. All special stages are **not allowed to be driven more than 2 times**. Because SS1 and SS4, SS2 and SS5, SS 6 and SS8, SS7 and SS9 are identical, they shall be counted as one stage.

9.5 During reconnaissance the crews must comply with "T-2018", 2018 LARSC Regulations and their appendixes and Lithuanian traffic law requirements, drive such a way that no danger or inconvenience will be caused to the people residing close to the rally course. **Remind that** in Lithuanian Republic in non-residential areas on gravel roads speed limit is 70 km/h. Driving in the opposite direction is strictly prohibited in the special stages. The Organizer's appointed Officials, GPS Tracking Operators and police will check the speed during reconnaissance. Allowed speed may be reduced additionally by Organizer built road signs, which will be marked in the Road Book. Use of anti-radars is prohibited.

9.6 All infringements during reconnaissance, recorded by the devices and police or fact marshals, will be punished following section 12 of Lithuanian Automobile Sports Code. The penalties are stated in Appendix No.6 (Table of Penalties). The fine imposed by the traffic police does not reduce any of received fines. During reconnaissance exceeding the speed limit till 10 km/h is not considered as a breach.

9.7 Reconnaissance may be performed only by the vehicles, which meet the requirements of "T-2018" part 25.1 and are registered by the Organizer. During Administrative checking the crew must indicate all vehicles, which will be used for reconnaissance, as well as the service vehicles.

9.8 All fines, appointed during Administrative checking, scrutineering, and reconnaissance **must be paid** till 12:45 hrs. 25-08-2018 (Saturday).

10.1.2 During Administrative checking all crews must indicate the number of the mobile phone, that will be in the car during the race available in order to be able to contact the crew in case of his stopping in the special stage.

XI. SCRUTINEERING , SEALING AND MARKING

11.1 Pre-start scrutineering

Place: Mazeikiai Polytechnic school, Vieکشniai branch, Mazeikiu str. 80, Vieکشniai, 56.2399, 22.4968

Date: 24-08-2018 (Friday) *For Test stage participating crews* Time: 19:00 – 21:30

Date: 25-08-2018 (Saturday) *For Test stage not participating crews* Time: 8:00 – 11:00

11.2 During pre-start scrutineering participants (members of team) must present following valid documents:

- ❖ "Green card"/ valid User/driver civil liability insurance;
- ❖ Vehicle registration document;
- ❖ Technical inspection evidence document;
- ❖ Rally car certificate (passport) issued by the LASF or the ASN of other country;
- ❖ Declaration of safety equipment (Form.3);
- ❖ Declaration of used fuel (Form 4);
- ❖ Cars of FIA groups "A", „N“, „R“, Super 2000, WRC – FIA homologation form and all

appendixes, cars of national "SG" group - manufacturing plant representative description.

11.3 The crew must affix competition numbers and Rally stickers on their cars before scrutineering. Competition numbers and Rally stickers will be issued during the administrative checking. Beforehand issuing of start numbers and Rally stickers is available by pre-agreement with the Organizer.

11.4 During pre-start scrutineering will be performed inspection of driver's helmets and driver's safety equipment, and the Officials with identifying marks, may to perform it repeatedly during all rally time.

11.5 FHR (Frontal Head Restraint) device is mandatory for all crews.

11.6 The crews can personally reserve the desired time for administration and technical checkings in electronic entry form on website www.aurally.lt from 15-08-2018 (Wednesday) 15:00 till 17-08-2018 (Friday) 17:00 hrs.

11.7 Exact arrival schedule with appointed individual arrival times to administrative checking and to pre-start scrutineering will be published 20-08-2018 (Monday), 15:00 on websites www.mazeikiuask.lt, www.aurally.lt

XII. OTHER PROCEDURES

12.1 Official time of the rally – Eastern European summer time (CET +2, UTC + 3).

12.2 Start of the Rally Sprint:

Place: Square in front Viekšniai Municipality, Tilto str. 12, Viekšniai 56.2328, 22.5163

Date: 25-08-2018 (Saturday) **Time:** 13:00

All rally cars must be placed in the pre-start zone, located in front Viekšniai Municipality, Tilto str. 12, Viekšniai, 56.2328, 22.5163 **from 11:00 to 12:30 hrs.**

12.3 Official start list will be announced on the Official Notice board in Rally HQ and TC 0. Official start list for the second rally section will be announced on the Official Notice board in Rally HQ and TC 5C.

12.4 Time cards will be issued in TC 0 and TC 5D. Time cards will be collected in TC 5C and TC 9A. Early check-in without time penalty is allowed TC 5C and TC 9A.

12.5 GPS safety and control system. In special stages safety of all crews will be guaranteed by safety and tracking GPS equipment. Passage through the GPS safety and control equipment inspection posts, which specified in the Road book, is mandatory for all crews.

12.5.1 The procedure of issue and use of safety and tracking equipment. In pursuance to maintain safety, receive notifications of risk, and following to Regulations of the rally, during issuance of the Road Books for every crew will be issued safety and tracking GPS equipment, which will have to be used by each crew during reconnaissance and during the rally. Every crew is responsible financially for this equipment and **must to pay 200 Eur deposit fee.** Returning of the equipment after rally finish is **mandatory** in rally HQ, 25-08-2018 (Saturday), till 20:30. If a disordered, dysfunctional equipment is returned, or if it has been failed to return till the term, 200 Eur deposit fee will not returned. Allowed to dismount the GPS device after the rally finish in „Park Ferme“.

12.5.2 The use of safety and tracking equipment. The crews are responsible for installing of this equipment by themselves. The same device is used during reconnaissance also during the rally time. The device has to be installed inside the car before rally start, or if the crew takes part in the Test stage, before it's start. Safety and tracking equipment and information sticker have to be installed according to scheme specified in Appendix 7.

12.5.3 Safety and tracking equipment operating principles. Safety and tracking equipment will be connected with monitoring station, which will store all the transferring data. The device has autonomous power supply, which will maintain the functioning of this equipment during the entire event. Each device has its unique serial number, which will be assigned to every crew. Geographical position of every crew will be monitored during reconnaissance and during the race at Rally HQ. **Attention!** The device during it's operating time can spread specific radiomagnetic interferences what is typical for GSM connections. We recommend others sensitive for these disturbances devices existing in the car to install as far as possible in maximum distance from the Organizer issued device installation location.

12.5.4 Principles of sending “SOS” and “OK” signals. Indicated in Appendix 7 of this Regulations

"Installation and use of GPS safety and tracking equipment". For the infringements, regarding to sending order of "SOS" and "OK" signals, the crews will be fined according to 12 section of LASC.

12.5.5 All attempts of a crew to inhibit or influence GPS Safety and tracking equipment signals or operation during reconnaissance and/or race, will be reported to the Stewards, which will appoint penalties or will decide on expulsion of the crew from the competition.

12.6 Retired crews must inform the Rally Headquarters by phone number, indicated on GPS sticker or Clerk of the Course by ph. +370 612 50791 about the reasons as well as place and time of their retirement. Retired crew must also return the time card at the closest control post or to the stage opening marshals, and remove the race numbers from the car. Failing to inform about retirement will inflict monetary penalty.

12.7 In case of an accident where the crew members or the spectators suffered physical damage/injury, the members of the crew must immediately inform by showing a sign "SOS" at least three next following cars (art. 40.2 of „T-2018“) and inform Rally Headquarters by phone number, indicated on GPS sticker or the Clerk of the Course by ph. +370 612 07151. The crews, if sees a showing SOS mark, or, if sees a crew who has a major accident and whose members are in the car and do not show any sign, **must stop immediately, inform Rally HQ** about it, and provide first aid to the injured crew. The crews violated requirements of using the "OK"/"SOS" signs will be penalized, following section 12 of LASC.

12.8 Red flag. This flag can be shown only in marshals radio points marked by appropriate signs. Upon seeing the first displayed red flag, the crew must immediately reduce speed and and ride safely by the reduced speed to the finish of the stage, following the marshals instructions. Flags will be displayed on all marshals points, located before the accident, in addition will be used and electronic signal of red flag in the GPS devices. Failure to comply with this rule will be penalized according to LASC Article 12 by decision of Stewards. The crew, which has been shown the red flag will be appointed the appropriate result according 39 part of „T-2018“.

12.9 All cars must have a red retro-reflecting triangle which, if the car SS stops due to an accident or technical failure, must be placed in a clearly visible place on the same side of the road, not less than 100 meters from the car, for that to warn other drivers.

12.10 If the crew retired from the Rally after the crash, the crew or team representatives must inform Chief Scrutineer Mr.Saulius Stanaitis, ph.+370 687 31023 and by his request deliver the car for technical inspection. Violating of this requirement will inflict monetary penalty.

12.11 Service.

12.11.1 During the Rally Sprint servicing of rally cars shall be allowed only in the Service park according T-2018 parts 48-52 requirements. Refueling allowed only in refueling zones according T-2018 parts 58.1-58.2 requirements. Entering to the Service Park is allowed: 24-08-2018 (Friday) from 19:00, 25-08-2018 (Saturday) from 8:00.

12.11.2 **Only one servicing car for crew** is allowed to enter into the Service park. Special sticker issued by the Organizer must be stick on the service car windscreen. Failure to meet this requirement will be treated a monetary penalty. Reconnaissance cars and representative cars are not allowed enter to the Service park. The trailers are allowed to be stored in the Service park.

12.11.3 **In the Service Park is prohibited to wash** the components and machineries, which are used technical oils (engines, gear boxes and similar). In the place of servicing the waterproof fabric (minimum 4x4 m) must be laid under the rally car. In the refueling zones is compulsory to have the tanks, for spilled fuel collecting. Using pumps for refueling, the ends of the tube must be equiped with safety taps or valves.

12.11.4 Test stage service.

In the Test stage Service zone are apply all requirements of clauses 12.11.1 - 12.11.3 of these Regulations.

12.12 Starting procedure in the Special stages. Time's interval between the crews is 1 minute during the rally. In all special stages the starting procedure will be executed by help of the electronic timing equipment. When 30 seconds are remaining till the start moment, for the crew is handed timecard. The electronic clock shows hours, minutes and seconds. When 5 seconds will remaining till the start, five red lights will light up every second from one to five. Then these five lights are extinguished, and the crew must to start. In case when the start is correct, lights green and continues to light for 20 seconds. In case of premature start - display shows "FALSE" and shows the time, what the crew carried out in early, before appropriate start time. If the electronic equipment is not installed or it is not functioning, the start procedure shall be carried out according „T-2018“ part 37.3 requirements. Marshal of the start must inform the crew that the start procedure will be performed without electronic equipment.

12.13 Regrouping. During the rally will be one regrouping with changing of the start list according SS 1–5 results after the first section.

12.14 Test stage (Shakedown) will be carried out 25-08-2018 (Friday) from 8:00 till 10:30.

12.14.1 The crews, wishing to participate in the Test stage, must indicate this in the electronic form, published www.autorally.lt no later than 17-08-2018 (Friday), 17:00 hrs. Maximum number of participants - 30 crews. If the number of participants will reaches 30, registration to the Test stage will be automatically stopped.

12.14.2 Test stage entry fee is 100 Eur, if it paid till 13-08-2018 (Monday), 17:00 hrs. Later this fee will be increased up to 150 Eur.

12.14.3 Distance of the stage – 3,50 km, road cover – gravel. Test stage (Shakedown) allowed to be driven no more **3** times for each crew.

12.14.4 The cars participating in Test stage must be conducted pre-start scrutineering. On the cars must be stucked Organizer's issued competition numbers, rally stickers and advertising stickers. In the car must be fitted GPS Safety and control device.

12.14.5 During Test stage, any person in the car performing the second driver position, but if he is not expressed the desire to participate in the rally, he must to sign the Organizer's presented consent form for own responsibility (Form 5).

12.14.6 During Test stage, all persons in the car must wear/use LARC (LARSC) safety regulations compliant helmets, clothing and safety equipment.

12.14.7 **The crew, who suffered a crash during the Test stage, must** inform Chief Scrutineer Mr.Saulius Stanaitis, ph.+370 687 31023, and by his request deliver car for technical inspection.

12.15 Sport clubs, entrants, their members and other physical or juridical persons who are willing to make hospitality zones for very important persons or other activities during Rally Sprint “Viekšniai 2018” have to get written Organizer's permission.

12.16 SS9 is "Power stage". According results of this stage respectively will be given extra points.

12.17 Park Ferme will be carried out just after the Rally finish, 25-08-2018 (Saturday). In "Park ferme" is allowed to dismount the GPS device after the rally finish.

12.18 The Organizer is not responsible for safety of the spectators, who gathered to watch the rally not in the Organizer's specified areas. All information relating to the safe rally monitoring, specified in Rally Guide 2, which will be published 17-08-2018 (Friday) on websites www.mazeikiuask.lt, www.lasf.lt, www.autorally.lt.

16.3 LARC 5th event participants, born in 1993 and later ("Junior" classification), 1st - 3rd place winners in „*Class Personal 1st drivers*“ classification, will be awarded the Organizer's cups, also the prizes, if they will established.

16.4 1st places winners of Rally Sprint „Viekšniai 2018“ 2WD and AWD classifications will be awarded as cups or prizes established by the Organizer.
